## Request for Proposal for Independent Third Party Code Reviewer

Proposals are Due no later than May 5, 2020 at 2:00 p.m.

### I. Project Scope Clarification

This project is an alteration / addition construction project with scope of the work defined by the Educational Specifications and by site and contextual requirements. The school will accommodate enrollment of 700 students in grades 7,8 and 9.

This project will be designed, and bid in four distinct phases as follows:

**Phase 1** – Early Demolition / Enabling. This was enabling work for Phase 2, involving the removal selected ceiling areas and minor above ceiling work and has been bid. This phase has been completed.

Phase 2 – Construction of alterations and addition, of approximately 163,313 GSF, on the site of the existing Bennie Dover Jackson Middle School. Scope will include mechanical, electrical, plumbing and fire protection systems, lighting, technology, life safety and architectural finishes in select areas in the school.

**Phase 3** – Technology and Technology Equipment. This phase will include data and technology devices.

Phase 4 – Furniture and Fittings, exclusive of technology equipment provided in Phase 3 noted above.

The construction of the School will begin while the existing Middle School is operational and will be constructed in several phases as outlined by the Construction Manager, O&G Construction.

The site and building will be designed in conformance with Connecticut High Performance Building requirements, per Public Acts 06-187 Section 70, 07-213 Section 5, 07-242 Section 10, and 07-249 Section 15.

**Phase 2** consists of project site work, demolition and abatement, alterations to the existing school and construction of new addition to provide space for the projected enrollment of 700 students on the existing Bennie Dover Jackson Middle School site. This scope will be publicly bid, per State guidelines and requirements, as a construction management at-risk project.

The project includes some outdoor play surface and field improvements, parking, accessible pathways and markings.

- **II. Question #1:** In reviewing the RFP, it is unclear if this for strictly code review of the entire project or an Independent Structural Engineer Review (ISER) of the project. Can you please clarify?
  - **a.** This RFP is strictly for 3<sup>rd</sup> Party Code Review of the entire project. Independent Structural Engineer Review (ISER) is not included in the RFP.
